<u>6.</u> Disability

Persons with disabilities include those who may experience barriers to full participation in University life as a result of long-term, temporary, or episodic physical, mental/emotional, sensory, or learning disabilities, including those caused by chronic health conditions. It should also be noted that the social model of disability recognizes that disability is not created by any medical or physical condition, but rather by societal barriers. A disability may be evident or nonevident.

Some examples of disabilities are noted below. Please note that these definitions follow medical definitions of disability.

- Deaf, deafened, hard of hearing
- Learning disability
- Mental health disability (e.g. anxiety disorder, bipolar disorder, chronic depression, schizophrenia, etc.)
- Mobility disability (e.g. amputations, paraplegia, reliance on walker/ scooter/ or mobility aid due to disability)
- Speech impairment (e.g. aphasia, cluttering, stuttering, etc.)
- Vision loss or impairment / legally blind (not correctable by glasses or contact lenses)
