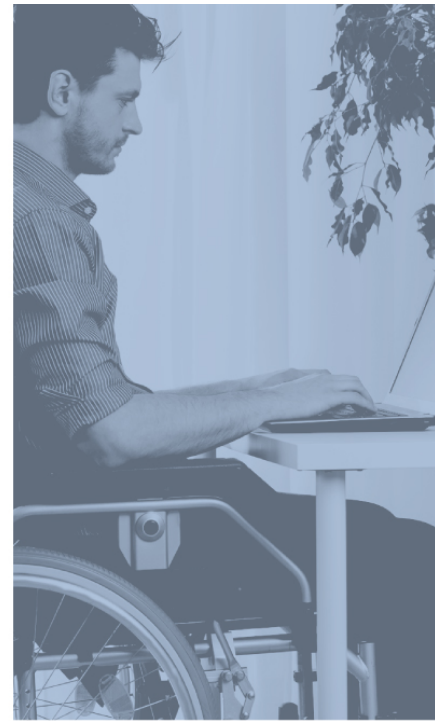

# Insight Grants – Objectives & Features

---

## APPLICANT

Principal Investigator  
Co-applicants and/or Collaborators

## DURATION

2 - 5 years

## VALUE

\$7,000 - \$100,000 (Stream A)  
\$100,001 - \$400,000 (Stream B)

## FUNDING

No separate envelope for Emerging Scholars

**October 15, 2019 (8 p.m. eastern)**

*Formal Application (check internal deadlines)*

# Multiple Applications

---

Normally, researchers may not apply, as an applicant, for an Insight Grant and an Insight Development Grant within the same calendar year.

- In 2017, SSHRC approved an exception to this regulation to allow researchers who applied **unsuccessfully** for an Insight Development Grant in February 2019 to apply for an Insight Grant in October. SSHRC will extend this exception to the multiple applications regulations for the foreseeable future. Therefore, researchers who applied for an Insight Development Grant in February 2019 and **were not successful** may apply for an Insight Grant in October 2019.

# Multiple Applications

---

## **Grant Retention:**

- No limit to the number of applications on which a researcher may be listed as a co-applicant or collaborator.

## **Re-application:**

- If you have a grant, you may re-apply to the same funding opportunity in its final year (or in the extension year).

# Joint Initiative for Digital Citizen Research

---

- New joint initiative between SSHRC and Canadian Heritage, part of Canadian Heritage's Digital Citizen Research Program
- Aims to support social sciences and humanities research within the Program
- Funds research related to online disinformation and other online harms as well as their impact in the Canadian context.



# Joint Initiative in Digital Citizen Research

---

- **Grants:** min \$7,000 – max \$250,000 over 3 years (max \$100,000/year)
- **Supplements:** up to \$20,000 to successful Insight Grant recipients, in addition to the value of grant
- How to apply.

# Joint Initiative for Digital Citizen Research - Application Process

---

- Applications are adjudicated by SSHRC's merit review committees
- Applications ranked above the fifth and sixth sextiles are referred to Canadian Heritage for a relevance review to assess whether the research adequately addresses the objectives and specific research areas of the Initiative

# Department of National Defence Research Initiative

---

- SSHRC and Defence Research and Development Canada (DRDC), an agency of the Department of National Defence
- Supports social science and humanities research aligned with areas of interest to the Canadian Armed Forces (CAF) and DND
- Fosters effective, evidence-based strategies, policies and programs in research areas identified by DRDC
- \$20,000 per year for 3 years (\$60,000 total) will be awarded to successful Insight Grant recipients

# Sport Participation Research Initiative

---

- Joint Initiative with Sport Canada
- Supports research on matters related to enhancing participation in sport
- How to apply
- Application adjudicated by SSHRC peer review committees
- If application is ranked above the fifth and sixth sextiles, it is referred to Sport Canada





# Sport Participation Research Initiative

---

- **Grants:** \$7,000 - \$250,000 over 3 years (max \$100,000/year)
- **Supplements:** up to \$20,000 to successful Insight Grant recipients, in addition to the value of grant. Funds conference participation at annual Sport Canada Research Initiative Conference

# SPRI Target Areas

---



## SPRI Target Area-Sport Participation

---

- Sport Canada allocating an additional \$75,000 in annual SPRI funding to support applied research on the sport participation of Indigenous children and youth.
- Sport Canada allocating an additional \$75,000 in annual SPRI funding to support applied research on the sport participation of women and girls.

# Societal Implications of Genomics Research

---

- Joint Initiative with Genome Canada
- Support social sciences and humanities research and related activities pertaining to research in the field of genomics
- Applications received will be evaluated on the basis of all other proposals received and Genome Canada will determine which applications are relevant.

- Applicants working with Canadian businesses and/or eligible not-for-profit organizations may be eligible for internship co-funding, through the [Mitacs Accelerate](#) program, for graduate students and/or postdoctoral researchers involved in their project.

## HOW IT WORKS

### 1. The match



A professor, partner organization, and student or postdoc develop a research project

### 2. The proposal



Applicants submit a [proposal](#) via a Mitacs representative

### 3. The project



Internships start at four months and can scale up as much as you need.



# Canada Foundation for Innovation (CFI)

---

- Funding of Infrastructure and research support via CFI's John R. Evans Leaders Fund.
- Eligible institutions wishing to apply to the John R. Evans Leaders Fund for infrastructure support associated with a SSHRC Insight Grant must submit separate proposals to SSHRC and to the CFI.
- Institutions can submit proposals requesting up to \$800,000 from the CFI, with a maximum total eligible cost of \$2 million.

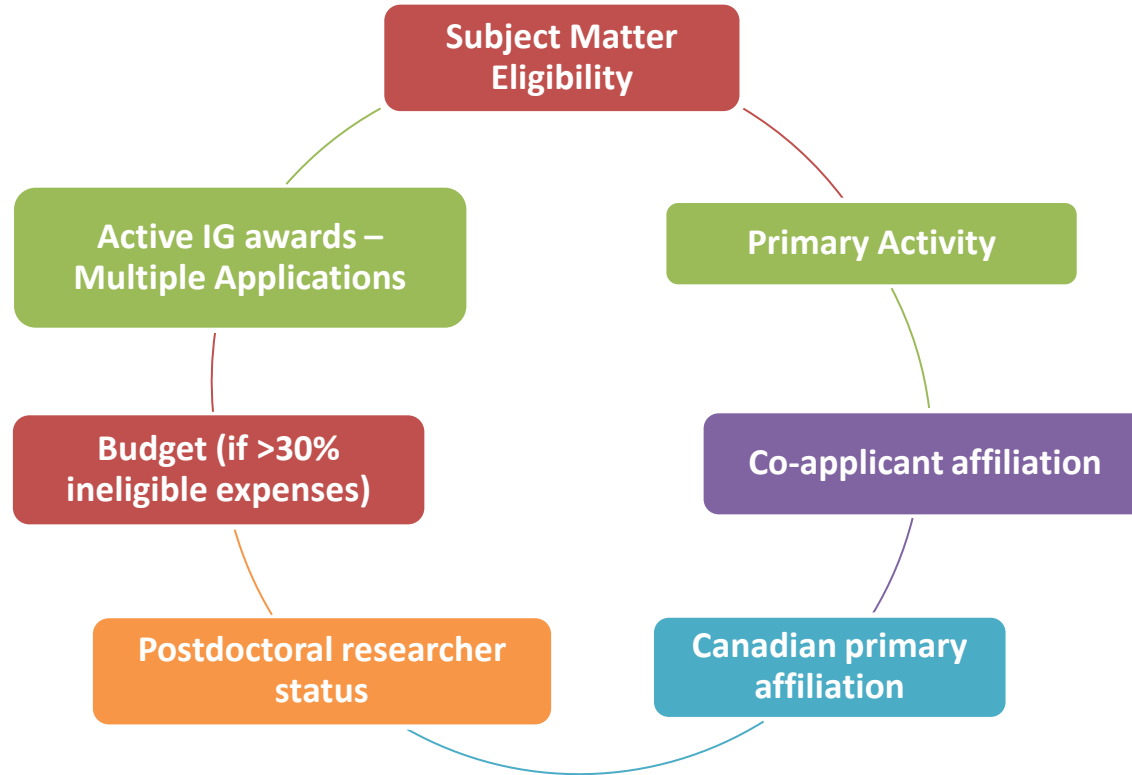

---



## Subject Matter Eligibility

---

- SSHRC does not support most health-related research, such as clinical research, research related to therapy, diagnostic tools, rehabilitation and epidemiology. Clinical education is also ineligible.
- For eligibility-related advice, applicants may send a summary (including the proposed objectives) to the IG inbox: [insightgrants@sshrc-crsh.gc.ca](mailto:insightgrants@sshrc-crsh.gc.ca).

---

- Inter/Multidisciplinary Humanities
- Inter/Multidisciplinary Social Sciences
- Request for Inter/Multidisciplinary Evaluation (max 1 page)
- Relevant expertise may also be sought from larger pool of Insight Grants committee membership

# Research-creation

---

- Approach to research that combines creative and academic research practices.
- Researchers, artist-researchers and teams of researchers & artists
- Committee 3: Fine Arts & Research-Creation
- Consult the Resource Centre for information on preparing an application involving research-creation.

## INDIGENOUS RESEARCH

*SSHRC is committed to supporting and promoting social sciences and humanities research by and with Indigenous Peoples, including First Nations, Métis and Inuit Peoples.*



# Indigenous Research Committee

---

- All academic fields, as well as domains of knowledge specific to FNIM cultural traditions
- Research involving both Indigenous and non-Indigenous perspectives
- Research by and with Indigenous Peoples
- Multidisciplinary committee composed of Indigenous and non-Indigenous members; all specialists in Indigenous research

# COMMITTEE MEMBERSHIP

---

- Expertise drawn primarily from the academic community, as well as the public, private, and/or not-for-profit sectors, as appropriate.
- Number of committee members is a function of number of applications received.
- Representation in terms of:
  - Research expertise (disciplinary or sub-disciplinary)
  - university size
  - geographical region
  - language
  - gender

# Adjudication Components

---

## ↘ External Assessors

- 2 assessments per application, where possible
- Suggested Assessors
- Provide additional information to committee
- Committee factors in their opinions as they judge appropriate

## ↘ Excluding evaluators

## ↘ Committees

- 2 - 3 Readers

# Adjudication Process

---

- **Calibration exercise**
- **Submission of preliminary scores by Readers**
- **Preliminary ranking of applications**
- **Flagging process for applications ranked in the bottom 35%**
- **Committee discussion**
- **Final ranking of applications**



# Evaluation Criteria & Scoring

---

**Challenge (40%):** Aim and importance of the endeavour

**Feasibility (20%):** The plan to achieve excellence

**Capability (40%):** The expertise to succeed

Note	Description
5 - 6	Very good - excellent
4 - 4.9	Good - very good
3 - 3.9	Satisfactory - good
Below 3	Unsatisfactory

\*No weighting assigned to sub criteria.

# Budget Evaluation

---

## **Ensure proposed budgets are appropriate and well-justified**

- ↘ Principle of minimum essential funding
- ↘ Budget envelope
- ↘ Scrutiny of budgets during meetings

## Tri-Agency Open Access Policy

---

Peer-reviewed journal articles based on agency-funded research to be freely accessible within 12 months of publication, via:

- **Online repositories, or**
- **Open-access journals**

OPEN  ACCESS

## Open Access Costs

---

- Applicants should be precise and provide justification for the amount requested
- Consult journal website for up-to-date estimates of the costs associated with publishing open access
- Consult the Tri-Agency Open Access Policy On Publications :

# Feedback

---

Applicants will receive the following information in their results packages:

- Notice of Decision
- Notice of Award (if the application was funded)
- External assessments received
- Committee Evaluation Form (if the application was discussed)
- Competition statistics

# Application Preparation

---

## Response to Previous Critiques

- Opportunity to justify a choice made with regard to research plan **or explain how previous feedback was used to improve the current proposal**

## Summary of Proposed Research

- Important introduction; be clear, thorough, use accessible language

## Detailed Description

- provide clear and precise objectives
- include a complete and up-to-date literature review
- outline theoretical / conceptual framework
- ensure methodology makes sense in terms of objectives and personnel involved





# KNOWLEDGE MOBILIZATION PLAN

- Be creative, ambitious and provide justification
- Where feasible, reach out to the community or public
- See Guidelines for Effective KM



## Description of Team / Student Training Plans

- ↘ Demonstrate the need for the team
- ↘ Describe each person's role and justify their inclusion in the research
- ↘ A student's work must be meaningful
- ↘ Refer to *Guidelines for Effective Research Training*

## Budget & Budget Justification

---

- Automatic failure on Feasibility if 50% or more of request insufficiently justified and/or not appropriate
- Option of failure if 30% or more deemed inappropriate
- Be reasonable and justify proposed expenditures
- Relate clearly to research objectives and methodology
- Describe other sources of funding
- See [Tri-Agency Financial Administration Guide](#)

# SUBMITTING YOUR APPLICATION:

## Applicants

1. Complete and verify application and SSHRC CV
2. Ensure all participants have included relevant attachments
3. Submit application for institutional approval

## Co-applicants

1. Create and verify SSHRC CV
2. Accept the invitation and upload Research Contributions (PDF)

## Collaborators

1. Fill out a profile
2. Accept invitation

# Submitting your application

---

- Leave enough time... remember internal deadlines
- Complete all mandatory fields
- Attach all mandatory electronic uploads to the application
- **VERIFY AND PREVIEW YOUR APPLICATION!**
- Click the "Submit" button (i.e., Submit to Research Administrator) for institutional approval
- Institutions forward applications to SSHRC
- Mandate eligibility
- **NOTE: PhD students and postdoctoral researchers may submit their applications directly to SSHRC.**
