New CFREF Administration Guide

- An updated guide was published in December
 - Principles-based, to provide institutions more flexibility and to better align with TAGFA.
 - We have heard some concerns around the policy on transfer of funds (Competition 3). We are working with the three agencies to refine the approach regarding the inclusion of non-postsecondary institutions such as research hospitals.
 - Reminder: invoices, contracts and accountable advances are an acceptable mechanism to pay expenses incurred by other organizations.

Data tables	Evaluate CFREF program's performance and report to government.
Narrative questions	Provide feedback to support the initiatives' progress and prepare for midterm review. Not used to evaluate progress or compare initiatives.
Budget projections table	Ensure alignment with program's financial policies and to demonstrate a continuous need for funds.

 - Progress on actions taken to address systemic barriers
